Lilly Endowment names 17 more counties to receive CAPE grants; investment grows to \$186 million covering 44 counties

Lilly Endowment Inc. has named 17 more counties that will benefit from grants of up to \$5 million each to participate in the CAPE (Community Alliances to Promote Education) initiative. With this round, the Endowment has invested more than \$186 million in 44 counties during this competitive initiative, which began in 1999.

The CAPE initiative has encouraged the state's more than 90 community foundations to lead discussions and forums in their areas, engage in research, prioritize their area's most pressing educational needs and help devise plans to address them successfully. The community foundations then have submitted proposals for grants to them or to other charitable or educational organizations they endorse to implement these plans.

"All along the way, these county-based foundations have been 'front and center' in convening and encouraging their communities' citizens and organizations to take advantage of the CAPE opportunities to improve education," said Sara B. Cobb, Endowment vice president for education. "They have held public meetings. They have benchmarked their communities against state, national and international standards. They have sought a range of perspectives from parents and students to local, state and national education experts, from public officials and business leaders to higher education officials,

from social service organizations to arts groups – all to determine what efforts will make the most positive impact on improving education in their counties.

"The dedication and zeal of the community foundations and their colleagues have been truly inspirational," she said.

In this round of the CAPE competition, the successful applicants – from Elkhart and LaGrange counties in the north to Scott and Crawford counties in the south – zeroed in on reading proficiency and literacy, preschool educational preparation, arts and science interactive programs, greater family participation in education and lifelong learning, education needs of immigrants, technology capabilities and learning centers for all citizens. Altogether, the grants in this round total \$80.7 million.

In the first round of CAPE grants, announced last December, 19 counties received \$68.8 million. In the second round, announced in July, eight counties received \$32.9 million.

"Indiana's educational challenges remain daunting," Cobb said. "Nevertheless, we are heartened by this evidence that there is a growing awareness in Indiana communities that improving educational achievement is imperative for future prosperity and that in many situations fundamental new approaches and benchmarks must be used."

#### Addendum 1

Recipients in the \$68.8 million first round of CAPE implementation grants covered programs in 19 counties. Announced last December, the grantees were:

- ♦ Community Partnerships, Fort Wayne, \$5 million, endorsed by the Fort Wayne Community Foundation (focus on reading opportunities for preschool through third-grade children and their families)
- Heritage Fund of Bartholomew County, Columbus, \$5 million (build on countywide Community Learning System to provide opportunities for residents, from kindergartners to adult workers)
- ♦ Southeast Indiana Network for Education, Evansville, \$19,990,744, a supporting organization of the Community Foundation Alliance (Daviess, Gibson, Knox, Perry, Pike, Posey, Spencer, Vanderburgh and Warrick counties) (programs to raise low levels of youth and adult literacy, help at-risk youth, provide professional development for teachers, and improve communication among teachers, parents, students and communities)

#### Addendum 2

Recipients in the second round of CAPE (offered to 13 community foundations that were unsuccessful with their implementation proposals in the first round) were announced in July. Eight counties received grants totaling \$32.9 million. Grantees were the following:

- ◆ Community Foundation of Muncie and Delaware County, \$5 million (two programs that provide out-of-school educational support to elementary-through-high school students who are at risk of academic failure)
- Mount Vernon Community School Corp., Fortville, \$4,687,246, endorsed by the Hancock County Community Foundation (countywide, technology-based initiative through three programs targeting youth, adults and the community-at-large)
  Hancock County Community Foundation, \$300,000 (endowment fund for CAPE programs)
- ♦ Phi Delta Kappa, Bloomington, \$13,009,051, endorsed by the community foundations serving Lawrence, Martin, Orange and Washington counties (programs aimed at three areas: early childhood and family education, K-12 school improvement, and workforce and career development)
- ♦ Anderson University, \$4,886,180, endorsed by the Madison County Community Foundation (reading initiative including two programs targeting 12 of the county's lowest-performing elementary schools)
